Terms & Conditions:

- Admission to this program is at the discretion of Mark Fainblum.
- This High Performance Junior Tennis Program is a 37 week (minimum two (2) days per week) obligation. Once registered, there is a no refund/no cancellation policy except in the event of injury or illness (see below for details).
- Cancellations will only be considered in the event of an injury or illness that prevents the player from participating for the remainder of the program. Appropriate medical documentation will be required and approval is at the discretion of the program. For approved cancellations, refunds will only be issued once a suitable replacement has registered and will be pro-rated based on the start date of the new player.
- There will be no refunds for any sessions missed by participants during the program.
- All High Performance Junior Tennis Program participants must be Mayfair Clubs members upon joining the program.
- Walk-on privileges are reserved for those meeting the minimum program requirement of two (2) days per week. Participants cannot reserve the court, but must book the court through Front Desk prior to accessing. Those found to be on court without Walk-on Privileges, or those who haven't booked through Front Desk, will be charged the appropriate court fees. These privileges are available at both Mayfair Parkway and Mayfair East, but can be revoked due to misuse at the discretion of the club without affecting any financial obligation to the program.
